INFORMATION REGARDING VIDEO SURVEILLANCE PURSUANT TO ART. 13 OF EU REGULATION 2016/679 (“GDPR”)

1. CONTROLLER	Alcantara S.p.A. with registered offices at Via Mecenate, 86, Milan, Italy (“Alcantara”).
2. DATA SUBJECT TO PROCESSING	<p>The images taken and recorded by the perimeter and external video surveillance system, which is active 24 hours a day and installed at the Alcantara S.p.A. facility at Nera Montoro (Terni) (the “Facility”), as well as the Complex Manufacturing Area at the same Facility.</p> <p>Only those images taken by the video cameras which monitor the parking area and those images taken by the perimeter video cameras in the event of an alarm will be recorded automatically.</p>
3. PURPOSES FOR PROCESSING DATA	<ul style="list-style-type: none">• To protect the company’s assets and to ensure the safety of personnel who enter and work in the Facility and the Complex Manufacturing Area• To safeguard property and personnel in the parking area outside of the Facility reserved for Alcantara employees and in the parking area covered by the Complex Manufacturing Area
4. LEGAL BASIS FOR PROCESSING DATA	<p>The legitimate interest to:</p> <ul style="list-style-type: none">• protect the company’s assets• ensure a high level of security in Alcantara workplaces and in the parking areas indicated above
5. RECIPIENTS OF DATA	<p>Data may be communicated or made available to:</p> <ul style="list-style-type: none">• companies which provide security/monitoring and surveillance services• public security and judicial authorities• suppliers of ordinary maintenance services when working on the Facility’s video surveillance system. <p>Where necessary, third parties will be appointed Processors pursuant to art. 28 of the GDPR.</p> <p>Within the Alcantara corporate organisation, data will be processed by the Facility’s Management, by the Personnel Director, by the Facility & Security Manager, by Technicians on shift and by the Officials On-Call. All the aforementioned parties have been expressly authorised to perform processing and instructed on how to do it pursuant to art. 29 of the GDPR.</p>
6. DATA RETENTION PERIOD	<p>Recorded images will be kept for a maximum of 24 hours from being taken and they will then be deleted by being overwritten. Storing images for a longer period is permitted solely in the case of an anomalous event being reported or being detected by the video camera alarm. In this case, images will be kept for the minimum time needed to assess the report of the incident / to</p>

7. NATURE OF PROVIDING DATA	Providing data does not constitute a legal or a contractual obligation for the data subject. Access to the area under video surveillance automatically leads to the collection and, in the cases referred to in point 2, the recording and the storage of the data subject's image.
8. THE DATA SUBJECT'S RIGHTS	<p>By contacting Alcantara S.p.A. by email at privacy@alcantara.com, a data subject may, subject to identification:</p> <ul style="list-style-type: none">• request access to the images which concern him/her;• object to processing;• request that processing be restricted and/or that the images which concern him/her are deleted, where this is possible. <p>Data Subjects may also lodge a complaint with the competent Supervisory Authority (in Italy, www.garanteprivacy.it). Given the particular nature of the processing, and the intrinsic nature of the data processed (images collected in real time regarding an objective fact) some of the data subject's recognised rights may not be actually exercisable (the right to rectification, the right to update data and the right to data portability).</p>
